The McDaniel 11-16 SWD was originally permitted with a maximum injection pressure of 428 lbs on 6/13/2007 (doc #200112835). We are requesting that the maximum injection pressure be amended to 832 lbs per the following formula consist with the UIC guidelines: top perf is at 4984'.

$$(0.60 - 0.443) \times 4984' = 832.$$
