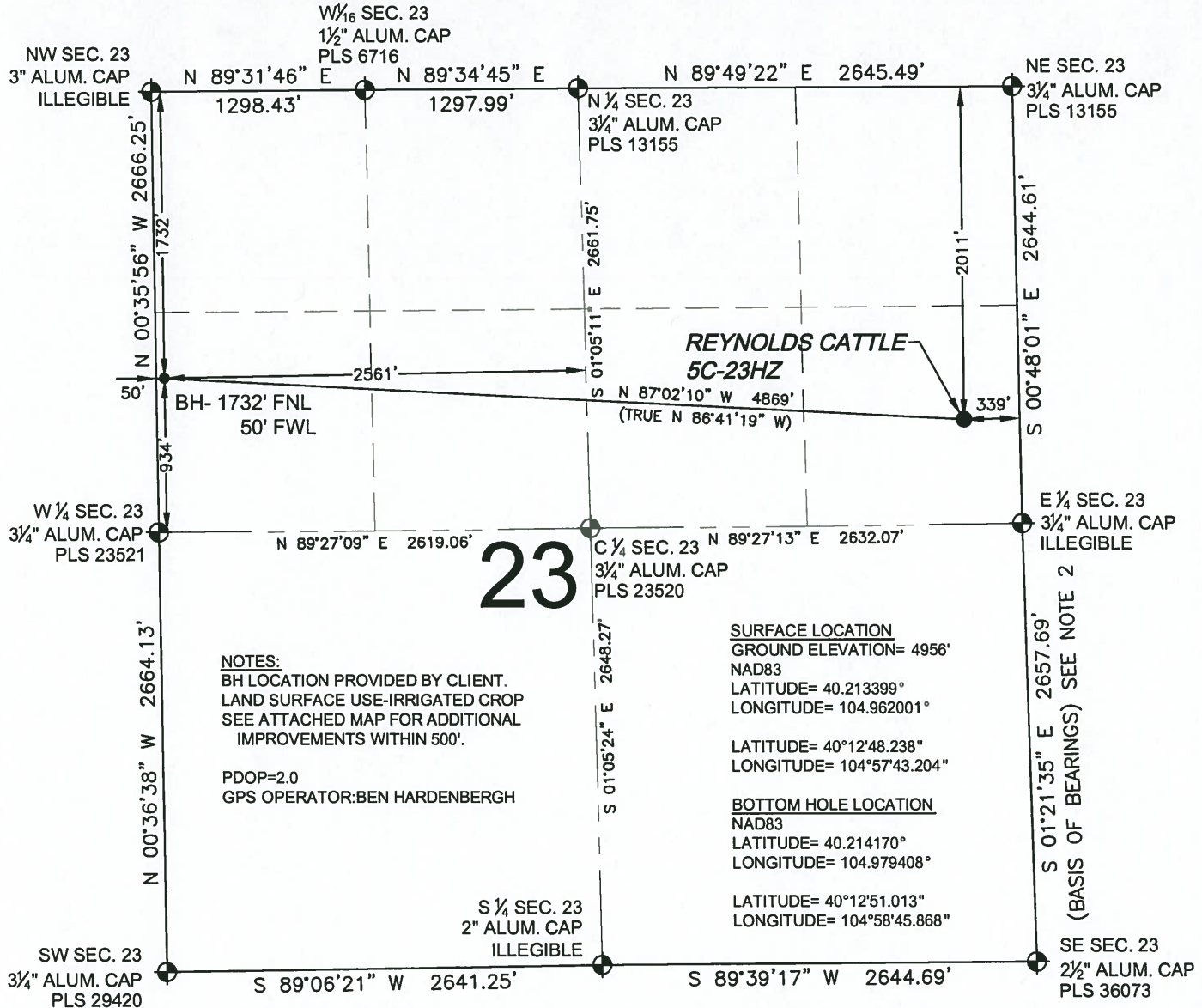


WELL LOCATION CERTIFICATE: REYNOLDS CATTLE 5C-23HZ

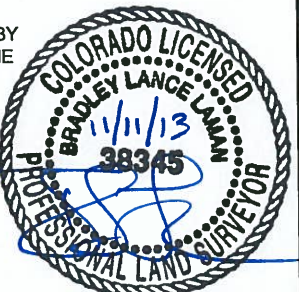
