	1) Verify existing cement with a cement bond log. 2) If Niobrara coverage not present, provide remedial cement 200' above Niobrara. 3) The Sussex and Shannon formations are productive within one mile of this well. Therefore, cement isolation, which does not currently exist across them, must be provided, by using a perforate and squeeze or equivalent method so that at a minimum there is cement from 50' above to 50' below the Sussex formation and 50' above to 50' below the Shannon formation. Or the cement volume may be increased to cover both formations. 4) If Fox Hills coverage not present, provide remedial cement from 770' to 330'. 5) The additional cement referenced shall be placed as indicated and comply with Rule 317.i. The placed cement shall be verified with a CBL and documented with a Form 5 Drilling Completion Report.
