Aurora Power Resources, Inc. intends to dispose of the mud and cuttings at an offsite location and as agreed upon with the private surface owner. The drilling mud and cuttings will be land farmed in the SWNE of Sec. 1 T4N R61W in Weld County, Colorado. All land farming will conform to COGCC rules and the cuttings will be tested to COGCC's Table 910-1 prior to any land farming. This land farming location will significantly decrease truck traffic associated with hauling. All surface owner agreements are in place.
