Planned surf csg setting depth: 3080' MD (3026' TVD).

WPX is currently drilling blind at 1765' MD with massive (3050+ bbls) losses and are having logistical issues rigging up an air package. We would like to set surface casing short (2700' MD) roughly 100' below the Wasatch top. The lowest known water source is the B Groove at 1111' MD. We are still planning on running a DV tool at 1350' MD. Our cement calculations are below.

Surface Casing 9.625; Depth Set 2631 (TVD); Depth Set 2700 (MD); Hole Size 14.75/13.5; Approx. Cmt Tail 1601; Tail Yield 1.96 (ft3/sx); Approx. Sx Tail 817; Approx. Cmt. Lead 238 (ft3); Lead Yield 1.70 (ft3/sx); Approx. SX Lead 140; and WOC 8 (Hrs).
