I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments:

- 1) In the Facilities section you indicated that a buried flowline will be used to connect the well. Please also provide me with a description of the number, size, and material of the flowline(s) that will be on this proposed oil & gas location.
- 2) In the Soil section you have only listed the (200) Vona-Karval-Midway NRCS Map Soil Unit, however, it appears your proposed oil & gas location area will also overlap onto the (194) Valent-Bijou complex as well. Therefore, please send me the NRCS Map Unit Description for this soil unit and I will add it to the Form 2A.
- 3) In the Water Resources section, you did not give a basis for your estimated depth to groundwater and the Sensitive Area determination. Please provide me with that basis and I will add it to the Form 2A.
