COMMENTS:

Kinder Morgan is requesting to drill ~80' below the bottom of the Leadville formation for logging purposes (to log the entire Leadville formation). A liner will be run and cemented and only the Leadville formation will be tested/completed. Kinder Morgan has just completed cementing production casing, is waiting on cement to cure and resume drilling sometime tonight. Verbal approval by Mark Weems and Larry Coler was obtained about 1130 and 1134 hours 3/3/2014 in 2 separate phone calls by Paul Belanger to explain above. Larry requested that the email exchange be attached as a pdf for documentation purposes. A DRAFT work-completed sundry, docnum 400565192, has been started as follow-up to this sundry with subsequent attachment of WBD when complete. Additionally a draft form 5, docnum 400565200, has been started and will be completed with the appropriate attachments within 30 days of completing this vertical pilot wellbore.
