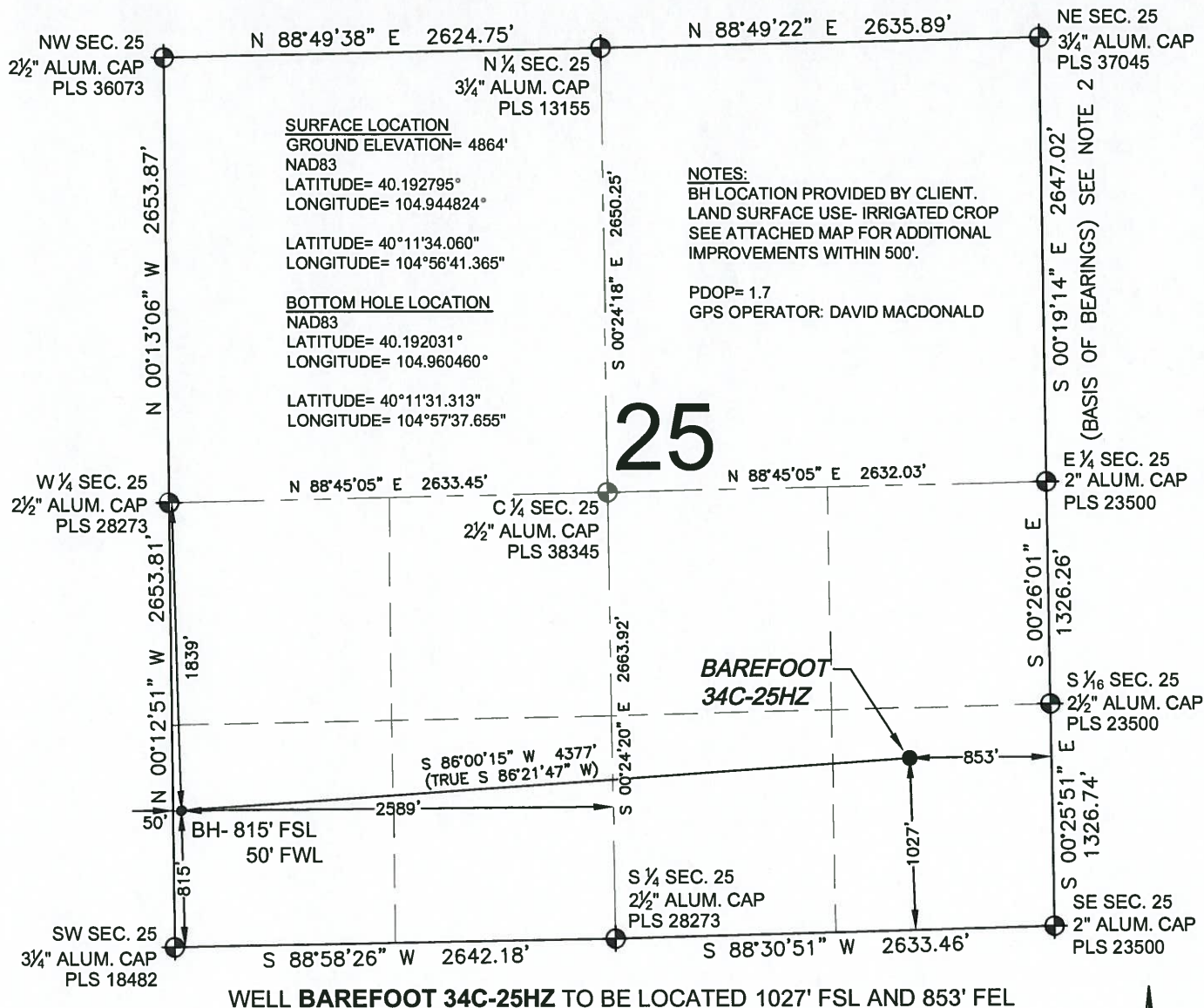


# WELL LOCATION CERTIFICATE: BAREFOOT 34C-25HZ
