Alex,

As discussed in our January 28, 2014 meeting, Marathon will not meet the March 3, 2014 Form 15 extension deadline for completion of all outstanding Form 28 actions and intends to continue operating the 32C Pond within all other COGCC regulations with COGCC oversight. Marathon proposes to submit to you on a weekly basis an e-mail that provides the status of pending actions and a timeline for working through the Garfield County Limited Impact Review process. This week's actions are as follows:

#### Status of COGCC Facility ID #433736

- 1) Financial Assurance - Submitted via overnight delivery on January 16, 2014, a bond rider in the amount of \$1,059,548 to Martha Ramos, Financial Assurance Supervisor of the COGCC for review and processing.
- 2) Site Plan – Submitted updated site plan via e-form sundry notice on January 22, 2014 (doc #400543605). Per COGCC, the site plan was reviewed by staff and approved.
- 3) Garfield County Limited Impact Review – Met with Garfield County Sr. Planner Glenn Hartmann on January 30, 2014 to discuss Marathon's 32C Pond Limited Impact Review application. Information was submitted to Garfield County at that time with the intent of satisfying the requirements outlined in the county's Technically Incomplete letter sent to Marathon dated December 20, 2013. The county will review this additional information and notify Marathon of any further outstanding actions. In addition, Marathon communicated our plan to continue operating the 32C Pond beyond the March 3, 2014 date, and encouraged an open dialogue between COGCC, Garfield County, and Marathon.
- 4) There were no environmental or safety events (incidents, near misses or good catches) this week at the facility.
