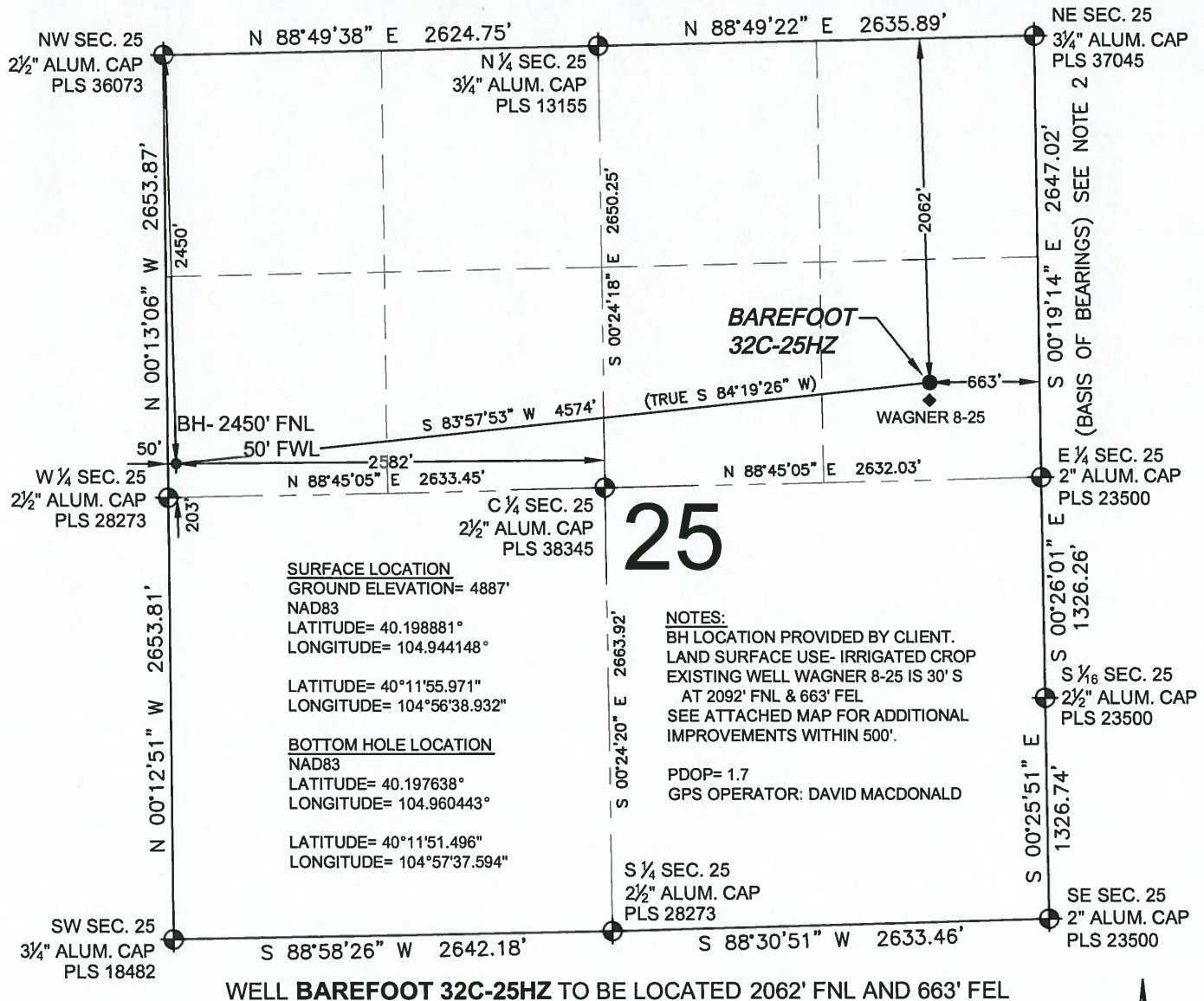


WELL LOCATION CERTIFICATE: BAREFOOT 32C-25HZ

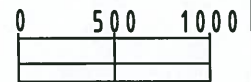
