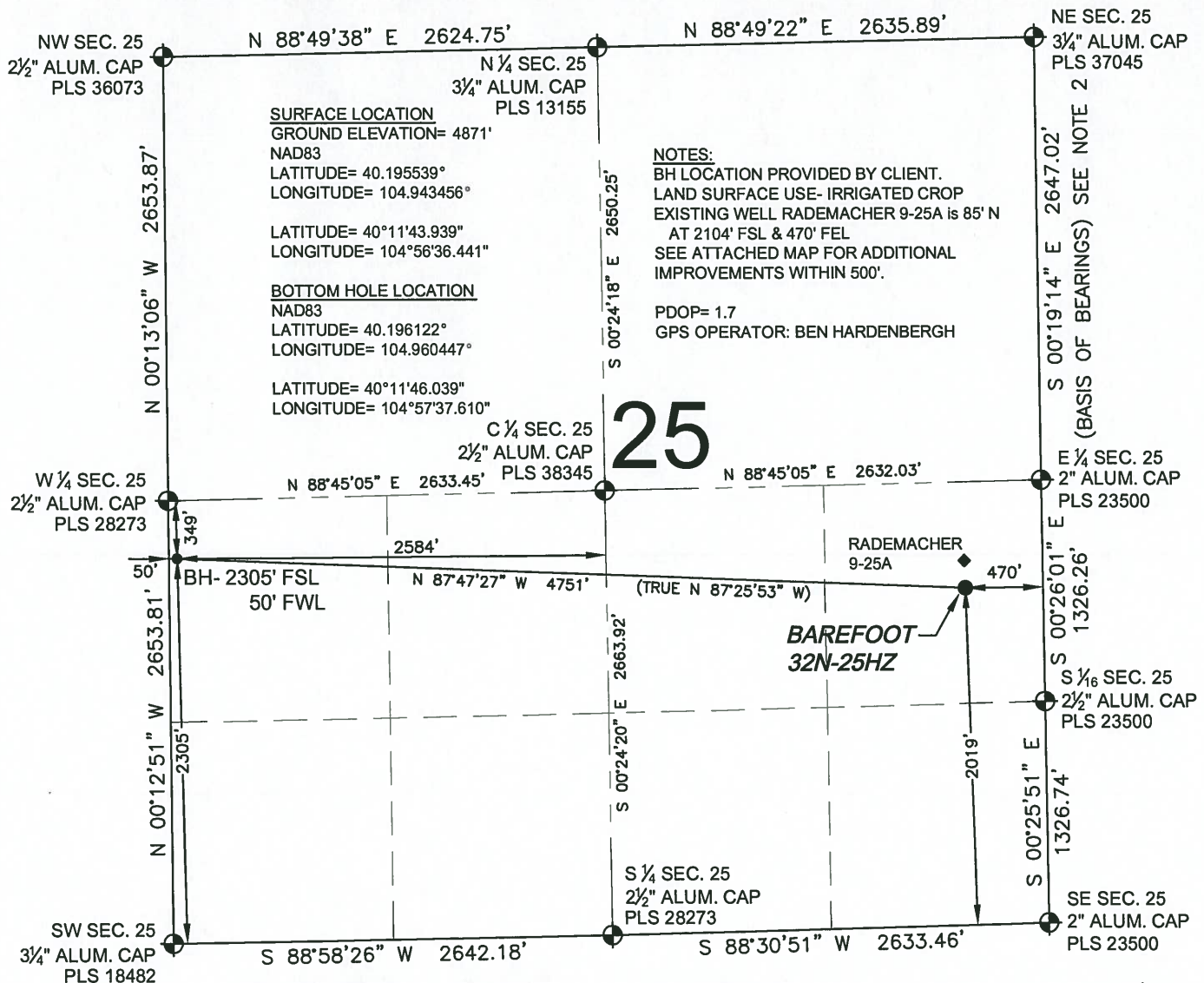


WELL LOCATION CERTIFICATE: BAREFOOT 32N-25HZ

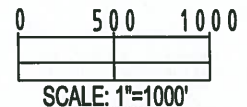
- ⊕ = EXISTING MONUMENT ⊕ = BOTTOM HOLE
