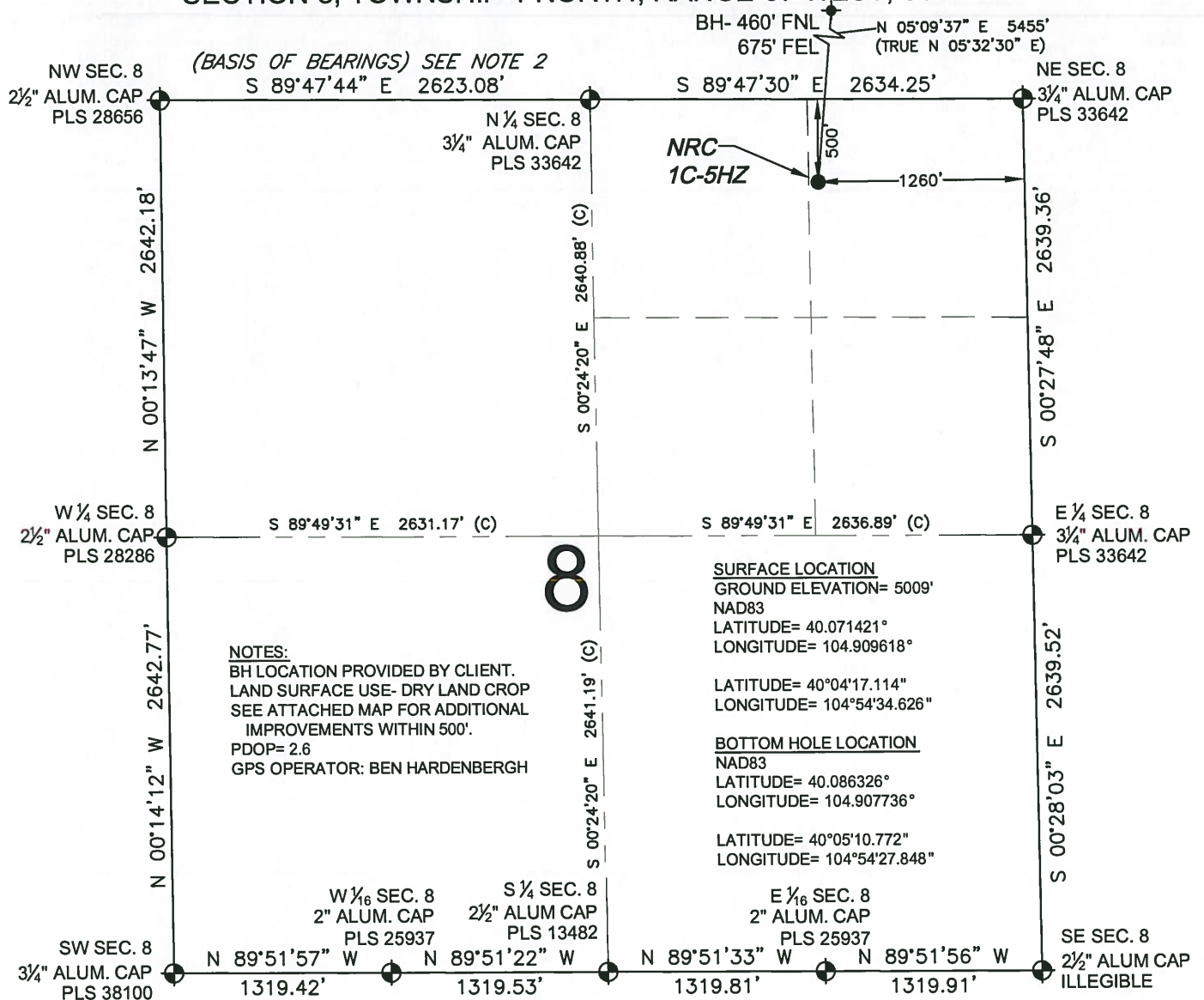


# WELL LOCATION CERTIFICATE: NRC 1C-5HZ

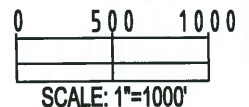
- = EXISTING MONUMENT    ♦ = BOTTOM HOLE
