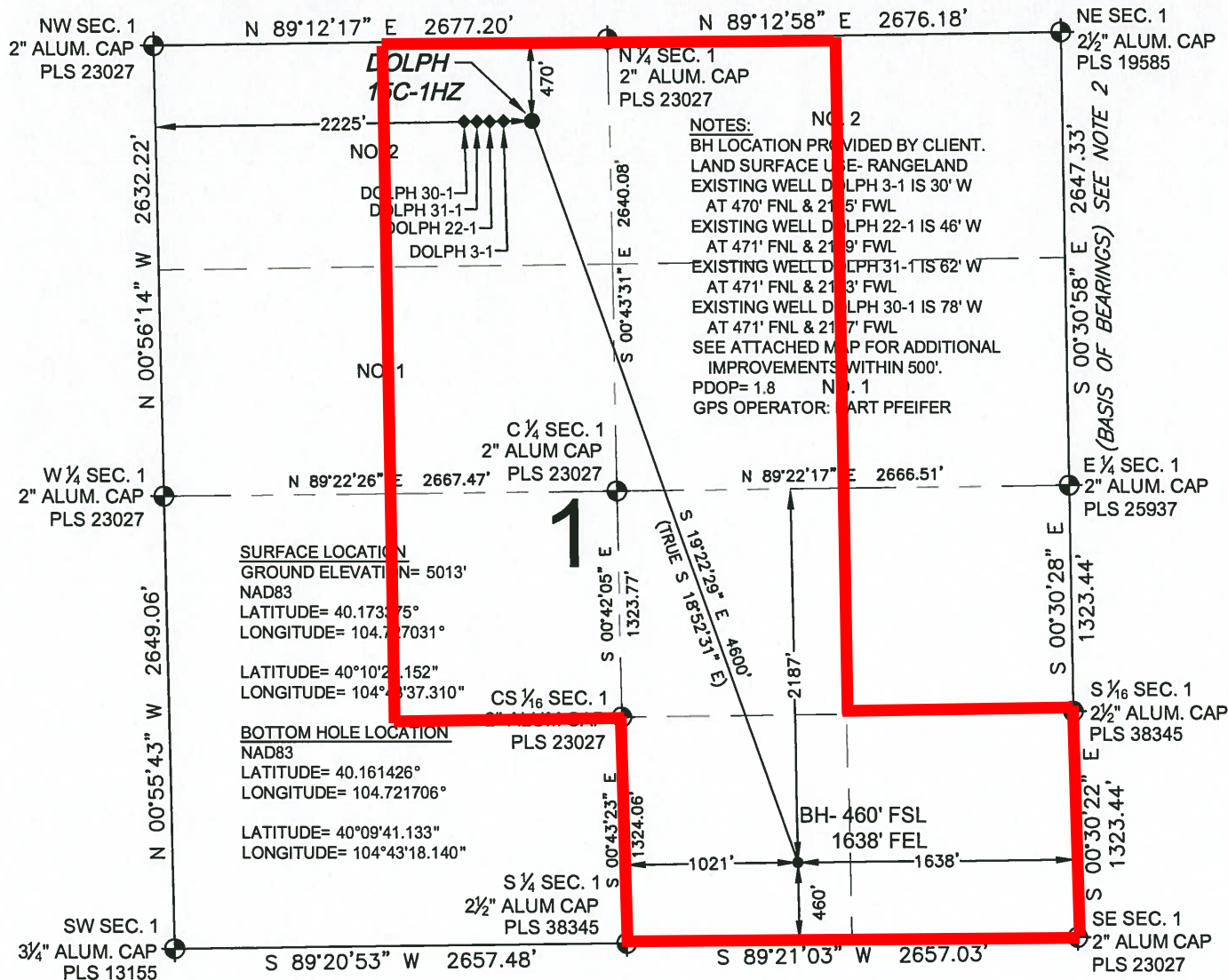

 BH = BOTTOM HOLE

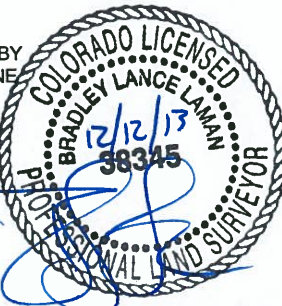
