"The proposed Peltier 1-11H by Continental Resources, Inc. was proposed to be approximately 50 feet north of the existing well known as the Peltier 11-12 (operated by Comet Ridge back in 2007). The Peltier 11-12 is not and has not been operated by Continental Resources, Inc. Continental Resources, Inc. has not constructed the pad site for the proposed Peltier 1-11H and no longer has plans to drill at the proposed location as approved.
