#### COMMENTS:

The following is the work conducted on the cement squeeze: Pull out of hole with 2 3/8" tubing. Pick up wireline retrievable plug and set plug at 1390'. Pressure test plug to 1000 psi, tested good. Spot 2 buckets of sand on top of plug. MIRU wireline and perforate 3 squeeze holes at 1274'. POOH and rig down wireline. Pump injection test with rig pump. SI well for night. MIRU cement company. Pump 75 sacks 16 ppg cement (1.14 cuft/sk) and displace with 19 bbls. Shut well in with 700 psi on casing. WOC. Bradenhead pressure 0 psi. PU bit and tubing and RIH to drill out cement. Drill out cement to 1372' and circulate well clean. POOH with tubing and RU wireline. Run CBL from 1360'-800'. New TOC 1256'. POOH with wireline. Pressure test squeeze holes to 1000 psi. Test good. RIH with retrieving tool and release retrievable plug, POOH with plug. Make up BHA and RIH with tubing. EOT at 4932'. RD rig and turn well over to production. Attached are the PJR and the CBL.
