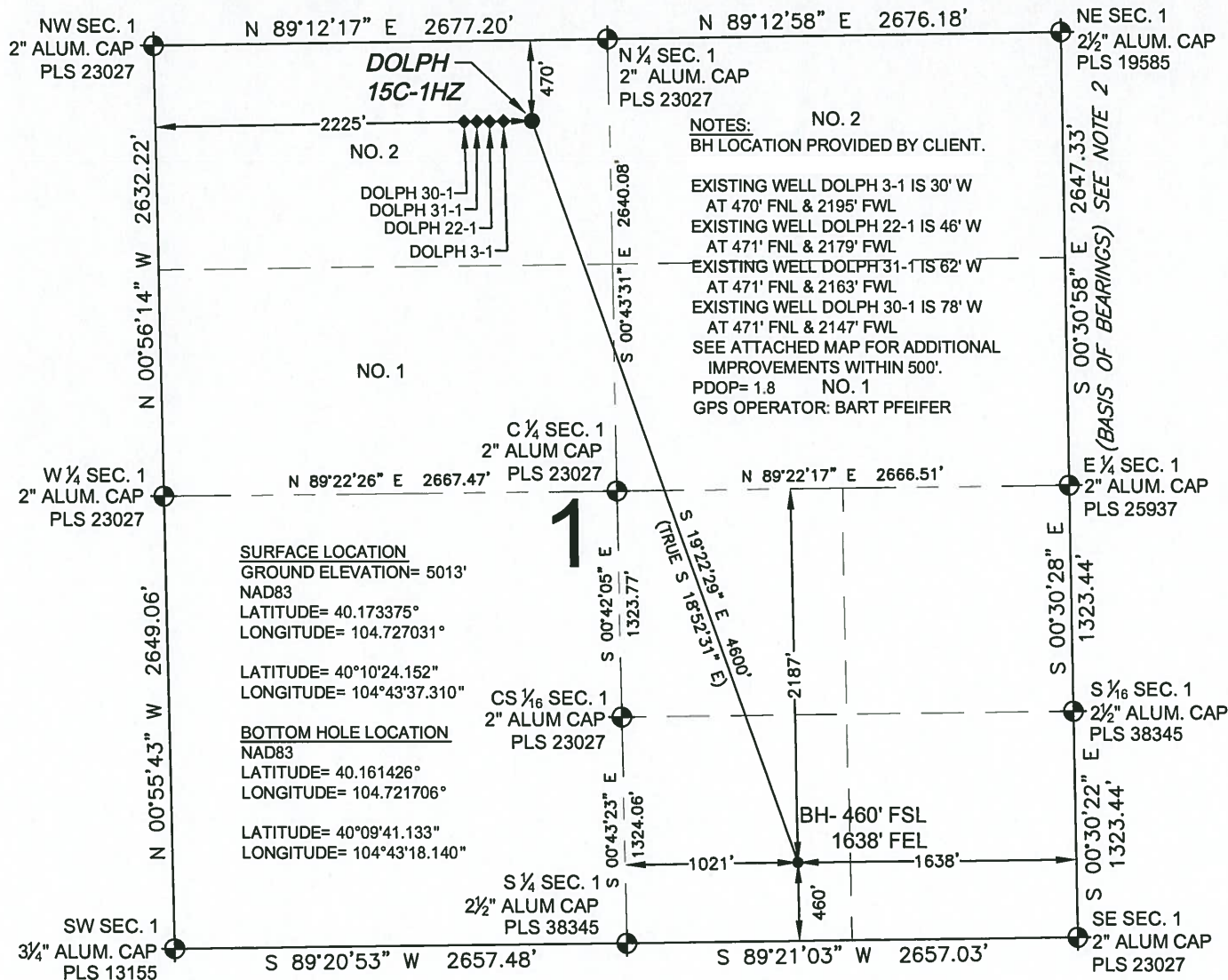


WELL LOCATION CERTIFICATE: DOLPH 15C-1HZ

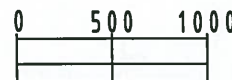
