COMMENTS:

Noble excavated impacted soil from the Ramos 1K produced water pit between 2/24/14 and 3/4/14. Soil samples were collected from the extents of the excavation to confirm soil exceeding COGCC Table 910-1 standards was removed. Laboratory analysis indicates BTEX, TPH (GRO/DRO) and arsenic in each of the samples collected from the excavation are in compliance with Table 910-1 levels or within background concentrations. Elevated levels of EC, PH and SAR were detected in soil samples, but were located at depths greater than 3 feet below ground surface. Approximately 850 cubic yards of impacted soil was excavated from the pit and transported to the South Canyon Landfill for disposal. The excavation was backfilled to the existing grade of the oil and gas pad on 3/14/14.
