Encana has recently acquired a larger, more efficient rig which requires a bigger drilling pad than previously needed. From a safety perspective, maneuvering heavy equipment, tools, and trucks in a confined space presents risks that can be mitigated by a slight size increase to the surface location. The File 32H-K268 location was originally permitted with a temporary area of disturbance of 10.5 acres. We would like to increase the temporary area of disturbance to 11.5 acres. The permanent area of disturbance shall remain the same as originally permitted. Please see attached location drawing for reference.
