COMMENTS:

1. MIRU workover rig. Control well in 10 bbl increments with clean 2% KCl.
2. ND WH, NU BOP. POOH with all rods and 2-3/8" tubing.
3. RIH with bit scraper and 2 3/8" tbq. Tag fill if any. Clean out to PBTD (tally in). TOOH.
4. Set packer ~300 ft above Parkman perforations and perform hesitation squeeze on Parkman perforations from 3523 ft – 3540 ft with 15.8 ppg G neat cement.
5. TOOH with cement tools. SI well overnight.
6. Drill out cement. Pressure test cement to 500 psi.
7. If pressure test passes, run new CBL recording new cement depths.
8. Drill out three CIBPs set at 3665 ft, 6402 ft and 6690 ft.
9. RIH with 2-3/8" tubing, rods and pump to produce well from the Nio and Greenhorn.
10. Turn well over to production.
