## COMMENTS:

This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the RGU 31-24-198 pad in accordance with footnote 1 to the COGCC table 910-1.

The request is based on the analytical results presented below (see attached laboratory report).

One composite sample was collected from three separate locations within the cuttings management area to determine the arsenic concentration in the cuttings.

RGU 31-24-198 (cuttings) - 4.6 mg/kg

Five grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.

RGU 31-24-198 -B-1 – 7.4 mg/kg

RGU 31-24-198 -B-2 – 13 mg/kg

RGU 31-24-198 -B-3 – 5.2 mg/kg

RGU 31-24-198 -B-4 – 5.4 mg/kg

RGU 31-24-198 -B-5 – 4.7 mg/kg

WPX Energy is requesting this approval in order to proceed with closure and reclamation of the cuttings management area located on the RGU 31-24-198 well pad.
