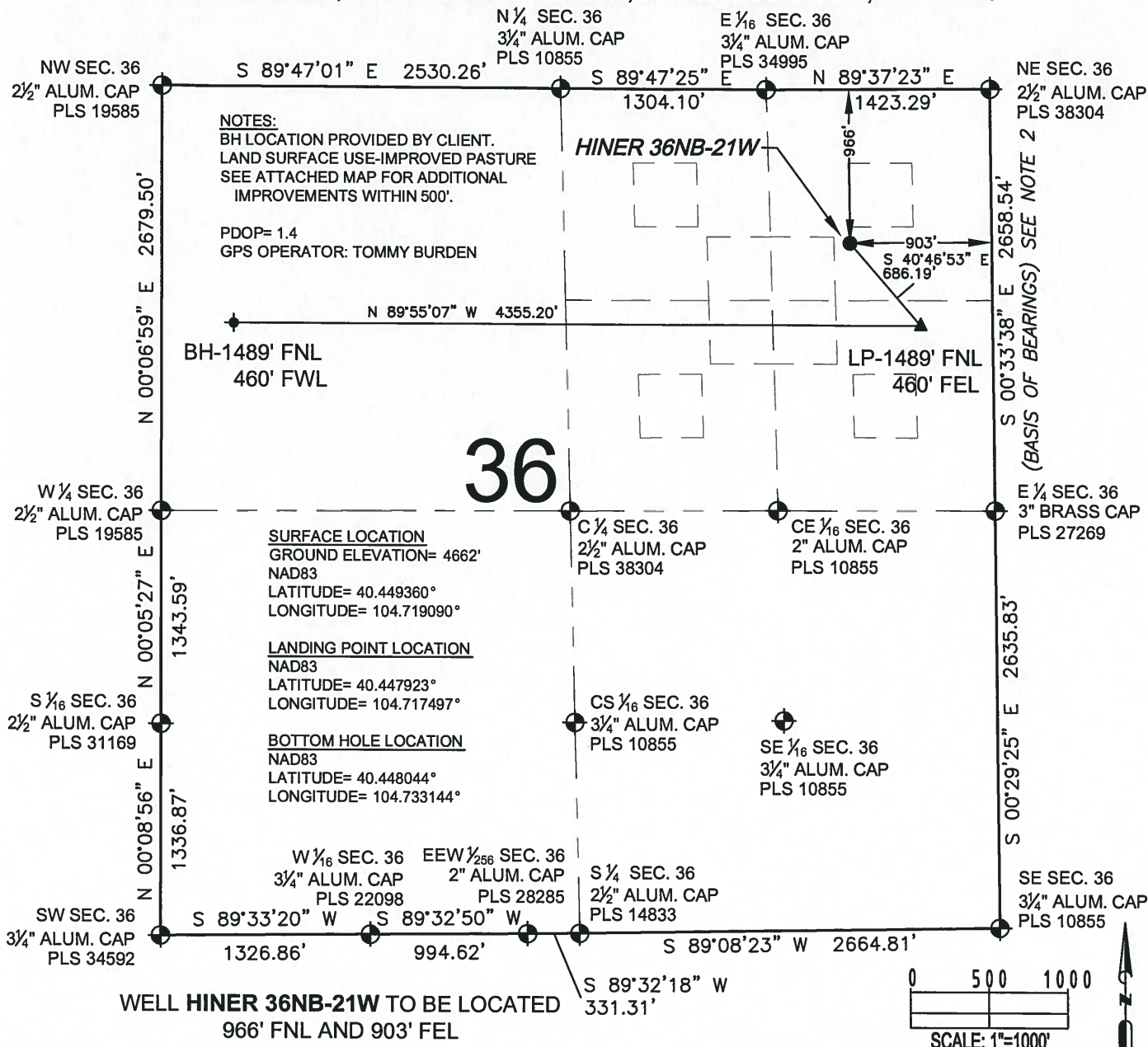


# WELL LOCATION CERTIFICATE: HINER 36NB-21W

## LEGEND

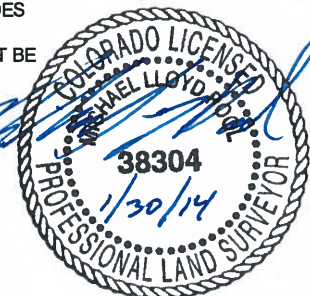
- = EXISTING MONUMENT    ▲ = LANDING POINT
