Carl,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) In the Facilities section you indicate there will be no Production Facilities on this proposed oil and gas location and in your pipeline description you indicate a flowline will run from the well to an existing tank battery. Please let me know where this existing tank battery is located and its Location ID # and I will include that on the Form 2A.
- 2) In the Construction section you indicate the date planned to commence construction is 3/15/14. Please provide me with an updated date you plan to commence construction and I will change it on the Form 2A.
- 3) Also in the Construction section you indicate the size of the location after interim reclamation will be 2.26 acres. This seems excessive given that you indicate in the Facilities section that only one well, pump jack, and electric motor will be on this proposed oil and gas location. Please either revise or explain why the size of the proposed oil and gas location after interim reclamation will be 2.26 acres.
- 4) In the Drilling Waste Management Program section you did not indicate where drill cuttings disposal will take place (Onsite or Offsite) and the method for drill cuttings disposal. Please provide this information and I will add it to the Form 2A.

Carl,

This email summarizes your responses to my four comments during our telephone conversation from this morning.

- 1) If the well produces it will produce to the tank battery at Location ID #433521.
- 2) The revised date planned to commence construction is 6/1/14.
- 3) The size of the disturbed area should not include the access road. The revised sizes of the disturbance are 2.75 acres during construction and 0.8 acres after interim reclamation.
- 4) Any cuttings from the cement will be disposed Offsite via Commercial Disposal.
