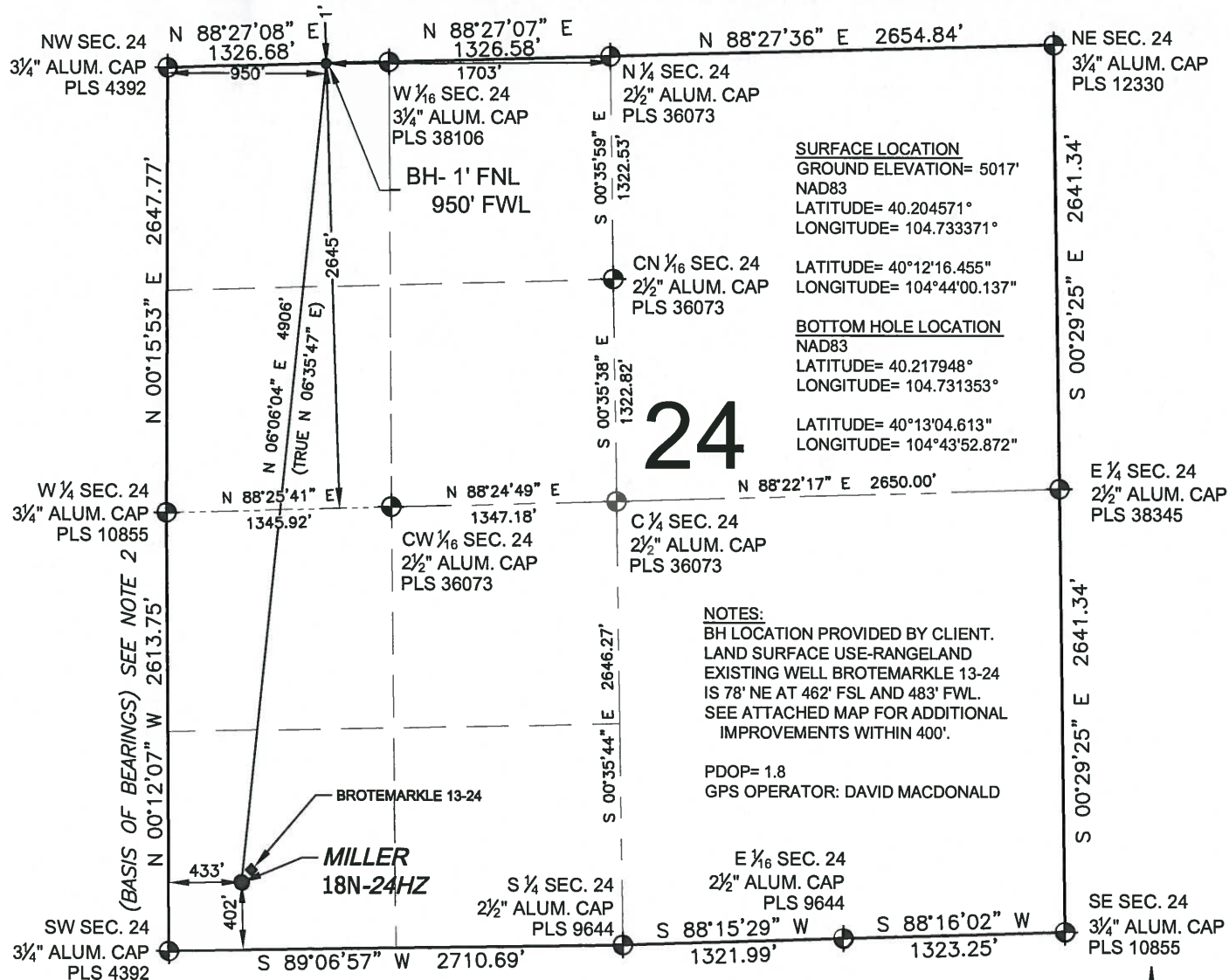


# WELL LOCATION CERTIFICATE: MILLER 18N-24HZ
