

PROCEED IN A SOUTHERLY, THEN SOUTHWESTERLY DIRECTION FROM BRIGGSDALE, COLORADO ALONG HIGHWAY 392 APPROXIMATELY 9.7 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 74 TO THE EAST; TURN LEFT AND PROCEED IN AN EASTERLY DIRECTION APPROXIMATELY 8.1 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 85 TO THE SOUTH; TURN RIGHT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 68 TO THE EAST; TURN LEFT AND PROCEED IN AN EASTERLY DIRECTION APPROXIMATELY 2.0 MILES TO THE JUNCTION OF THIS ROAD AND COUNTY ROAD 89 TO THE SOUTH; TURN RIGHT AND PROCEED IN A SOUTHERLY DIRECTION APPROXIMATELY 3.0 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE WEST; TURN RIGHT AND PROCEED IN A WESTERLY DIRECTION APPROXIMATELY 4.0 MILES TO THE JUNCTION OF THIS ROAD AND AN EXISTING ROAD TO THE NORTH; TURN RIGHT AND PROCEED IN A NORTHERLY DIRECTION APPROXIMATELY 200' TO THE BEGINNING OF THE PROPOSED FIDUCIAL 6-62-34 ROAD TO THE WEST; FOLLOW ROAD FLAGS IN A WESTERLY DIRECTION APPROXIMATELY 8,044' TO THE BEGINNING OF THE PROPOSED ACCESS ROAD TO THE EAST; FOLLOW ROAD FLAGS IN A EASTERLY DIRECTION APPROXIMATELY 274' TO THE PROPOSED LOCATION.

TOTAL DISTANCE FROM BRIGGSDALE, COLORADO TO THE PROPOSED WELL LOCATION IS APPROXIMATELY 31.4 MILES.
