Static water level was determined from water well permit #64343- -, located (NWNE) Sec. 6-T6N-R80W, approximately 2895' southwest from location. This well pumped at a rate of 20 gpm with a static water level of 18'. There is no elevation listed for this well, but topographic maps show it as approximately 21' below location. Correcting for this difference results in an estimate of 39' to groundwater at location. This is what has been reported above.
