**OPERATOR COMMENTS AND SUBMITTAL**

Comments 7" casing string will be cemented to at least 200' above Niobrara, around 500' from surface. CBL will only be run in the vertical section of the wellbore. Distance to nearest well Buderus 12-33 measured to via the Anti-Collision Report in the Deviated Drilling plan. PDOP value is equal to or less than 6.

Description of lost hole, rig skid, and unplanned replacement well: Drill pipe was stuck in hole at 12,468. After unsuccessful attempts to recover drill pipe and BHA, with drill pipe parting at 7,062' it was determined that it was not economical to continue fishing operations, and the possibilities of recovering more drill pipe are less than 10% it was determined to P&A the well.
