It is our intent to refract/recomplete the Codell and Niobrara formations in this well. This well was previously permitted and completed in the Codell and/or Niobrara formations (NB-CD).

1. MIRU Workover Rig
2. ND production equipment

5. TIH clean out to PBTD with bit and scraper
6. TOOHLaydown bit and scraper

8. \*Pressure test casing to 5,000 psi (Maximum treating pressure for frac operations)

10. ND casing hanger and unseat casing
11. TIH (annulus) with 1 1/4" workstring and tag TOC
12. Condition hole and bring cement to surface based on current industry best practices
13. NU casing hanger and reseat casing
14. Run new CBL to be submitted to state
15. Perforate/re-perforate Codell
16. Frac/ReFrac Codell
17. RIH w/ wireline w/ flow through plug & perf guns
