## OPERATOR COMMENTS AND SUBMITTAL

Comments This is a So Ute Tribal well with a constructed well pad on Tribal surface. Nothing has changed from the prior filing. The pad has been built on tribal surface.  
The pits have been constructed and have backfilled until drilling resumes.  
The well site will not require any expansion or additional disturbance of the pad.  
The location does not require a variance from any rules listed in Rule 306.d(1)(A)(ii); consultatin with CDPHE is not required.  
Although this is a Sensitive Wildlife area, a separate DOW letter has not been sent, the DOW notification for BP sites is covered by the San Juan Basin Colorado Wildlife Mitigation Plan (WMP) dated March 2011. This is a tribal site and falls under tribal jurisdiction as well.
