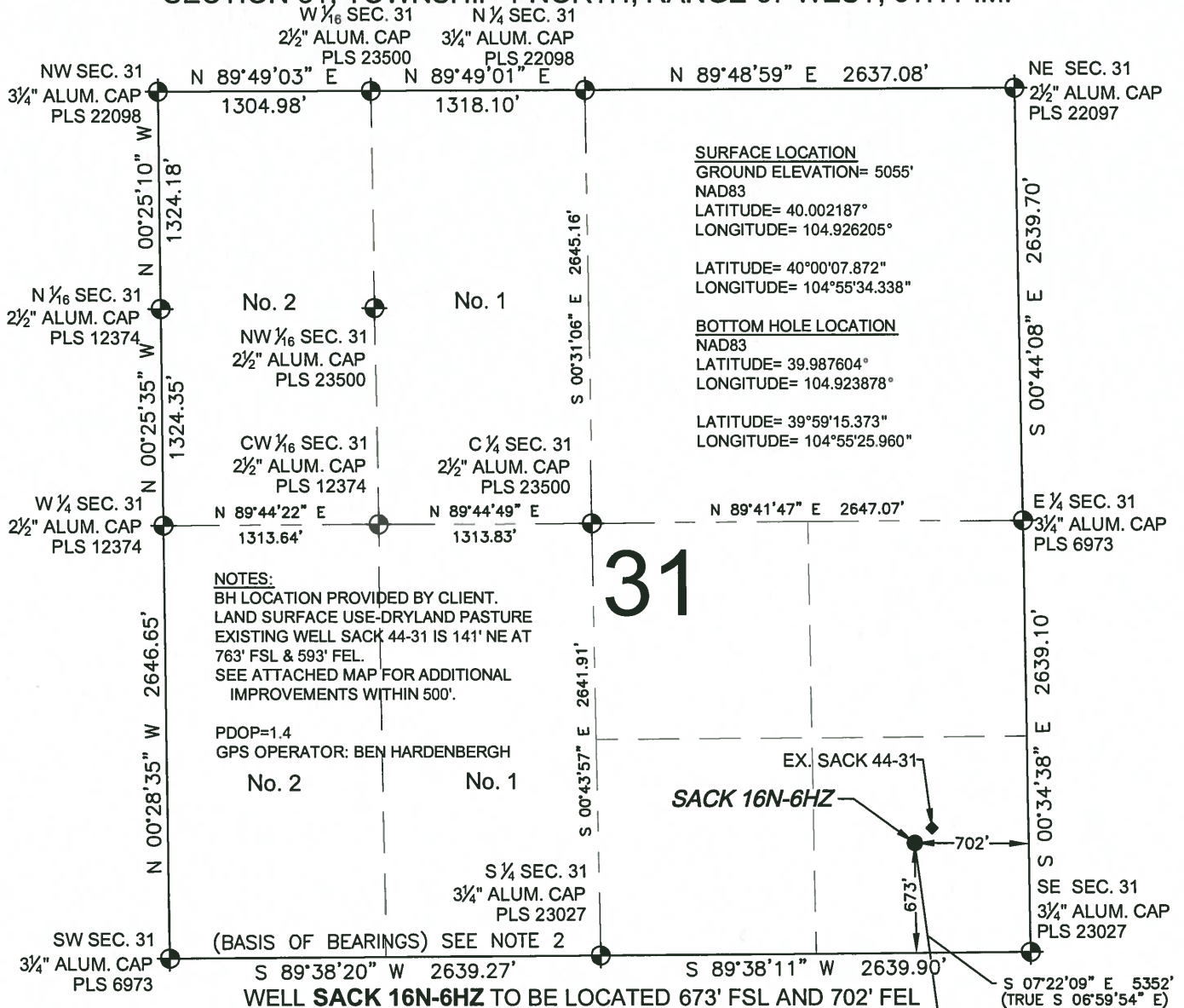


WELL LOCATION CERTIFICATE: SACK 16N-6HZ

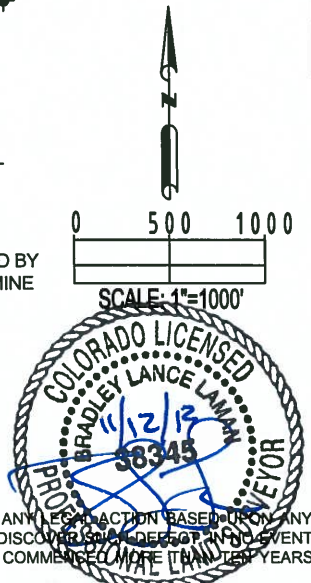

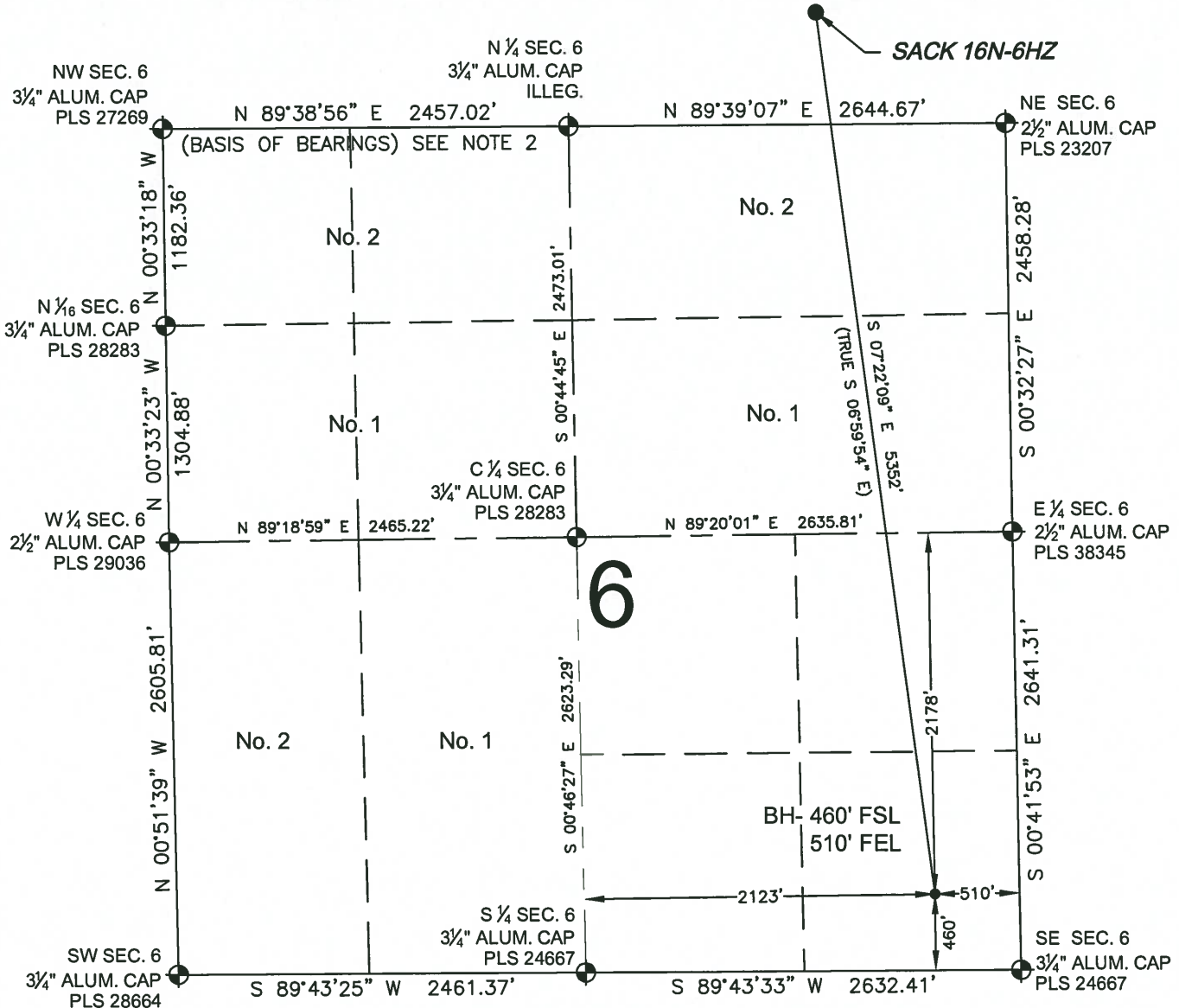
