COMMENTS:

Wesco Operating pulled this well and returned it to production with a new style of rod pump (in December 2012 a "FARR" type plunger was installed to combat sand problems), but the well produced less than 1-week. The well was shut in at this time. The well will be pulled and the production BHA will be brought up the hole 500 feet to combat sand problems. The schedule will be driven by rig availability, it is estimated the well will be brought back into production by May 1st, 2014.

By moving the pump up the hole 500 feet, it is hoped the sand will not interfere with the pumping system and allow the well to produce normally (although not optimally).
