Dear Mr/ Mehler:

Noble Energy Inc. ("Noble") plans to drill the Five Rivers K0867-1HN Horizontal Well (the "Well"), with a wellbore lateral as depicted on the enclosed plat.

Our records indicate that K. P. Kauffman Company, Inc. filed an APD for the following well which may be located within 150' from our proposed horizontal wellbore lateral:

RML 18-8, API 05-123-26543

Colorado Oil and Gas Conservation Commission ("COGCC") Rule 318A.m. provides that no horizontal wellbore lateral shall be located less than one hundred fifty (150') feet from any existing or permitted oil or gas wellbore, but this requirement may be waived in writing by the operator of the encroached upon well.

Noble respectfully requests that K. P. Kauffman Company, Inc. waive this requirement and allow Noble to drill the Well as proposed. Accordingly, by executing this letter, K. P. Kauffman Company, Inc. waives COGCC Rule 318A.m. and grants its consent to allow Noble to drill the Well within the 150' minimum intra-well distance provided for in said rule.

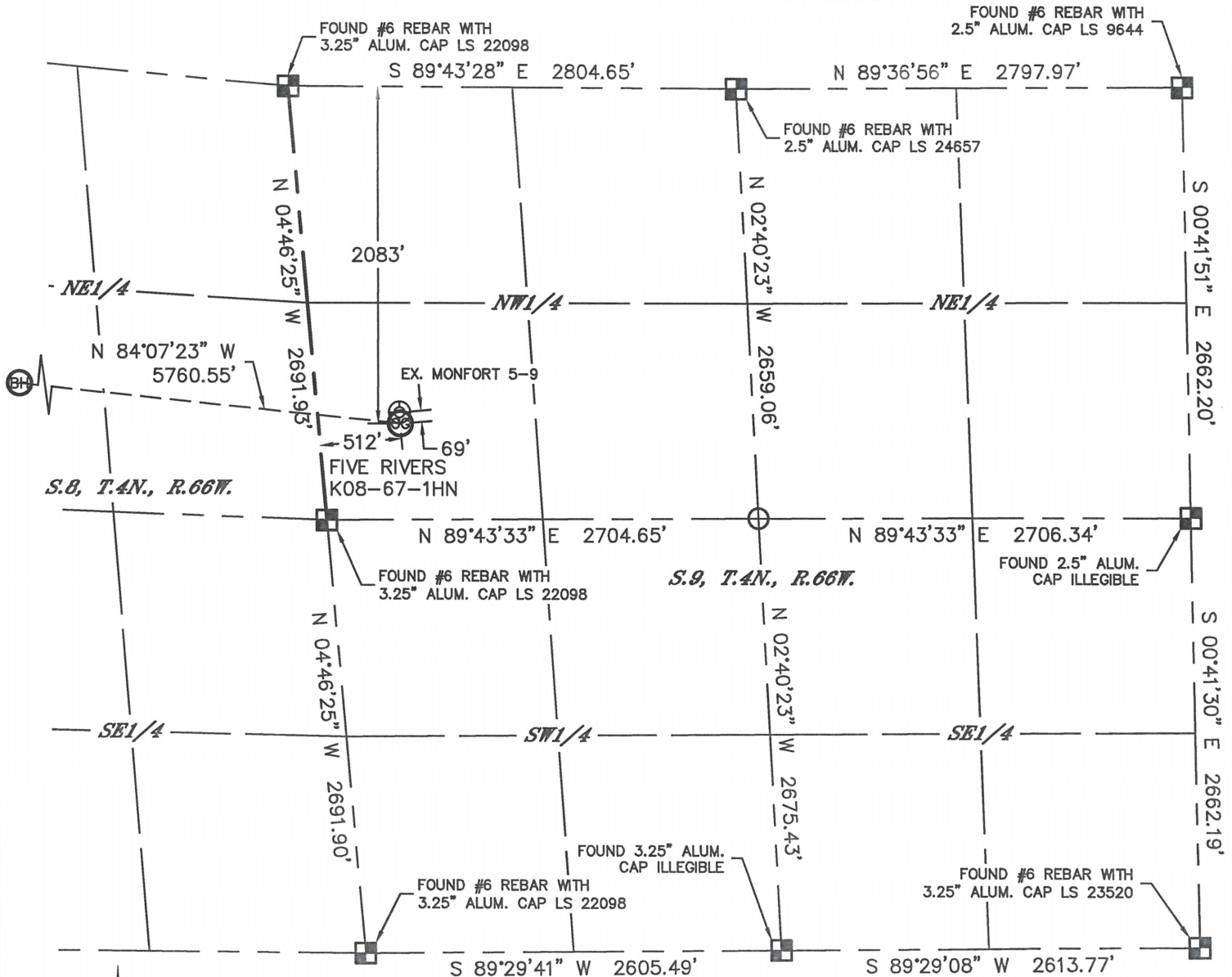

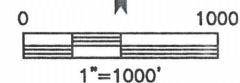

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 11/19/2013, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

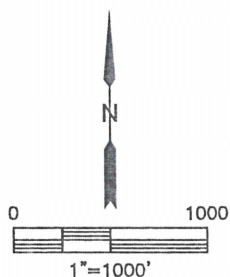
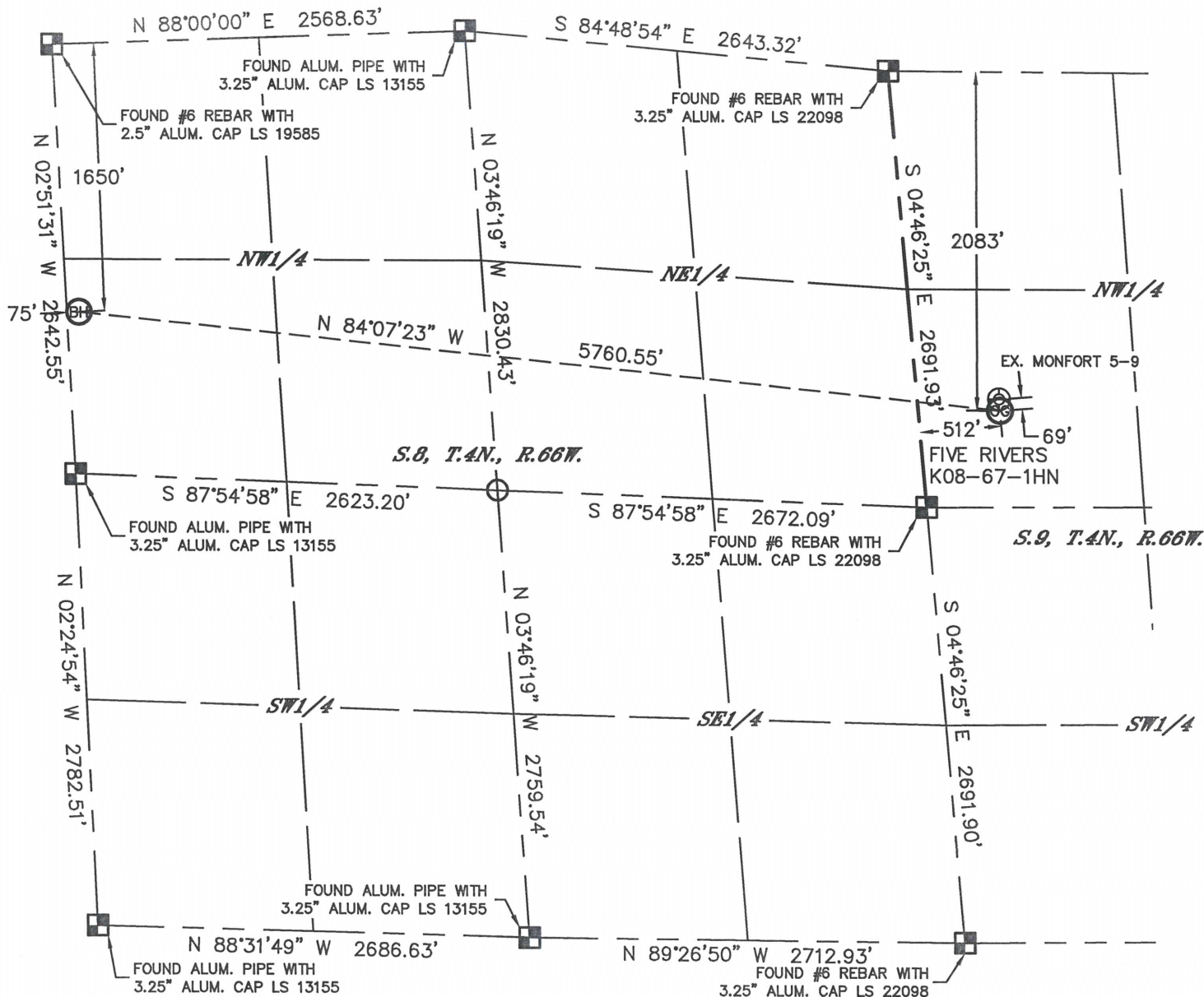

WELL LOCATION CERTIFICATE

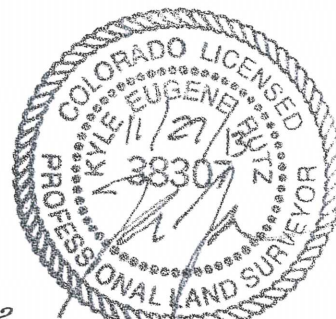
