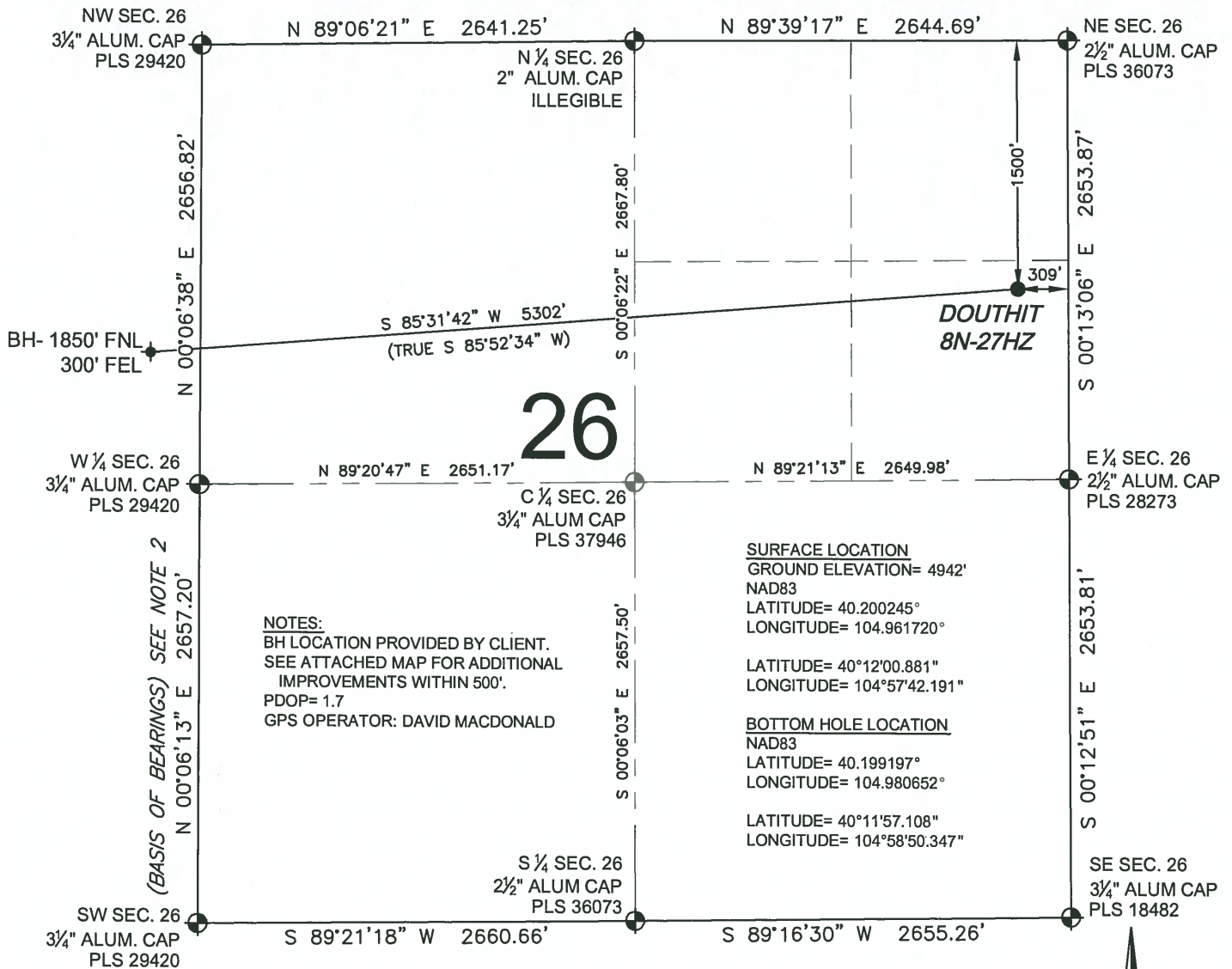


WELL LOCATION CERTIFICATE: DOUTHIT 8N-27HZ

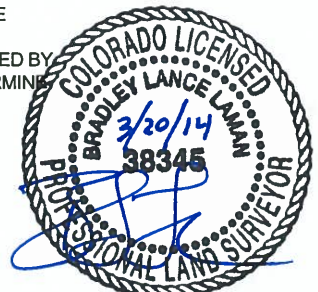

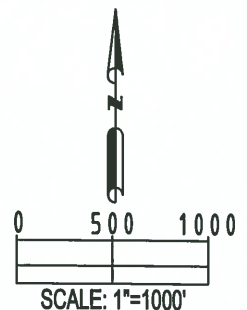
