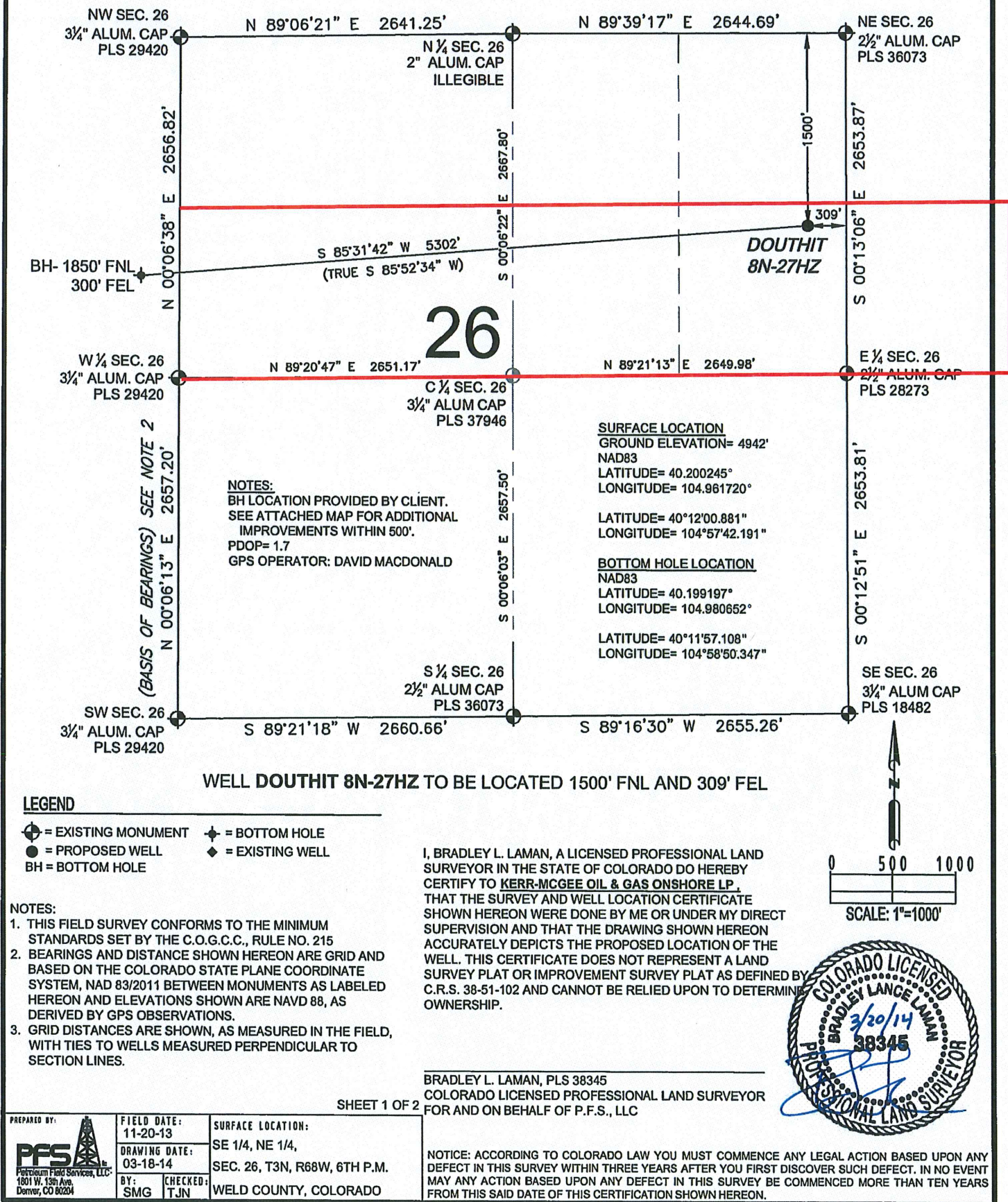

SECTION 26, TOWNSHIP 3 NORTH, RANGE 68 WEST, 6TH P.M.



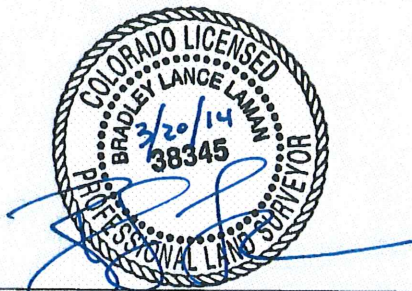
SECTION 27, TOWNSHIP 3 NORTH, RANGE 68 WEST, 6TH P.M.



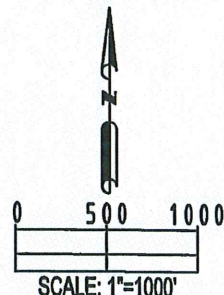
