Containing 160 acres

Bayswater is not the only owner within the proposed wellbore spacing unit and has provided notice to the remaining owner(s) within this spacing unit, as required by COGCC Rule 318A.e.(6). 

WELL KAISER B-10HC TO BE LOCATED 426' FNL AND 426' FEL, SEC. 10, T6N, R65W





WELL KAISER C-10HN TO BE LOCATED 438' FNL AND 418' FEL, SEC. 10, T6N, R65W


