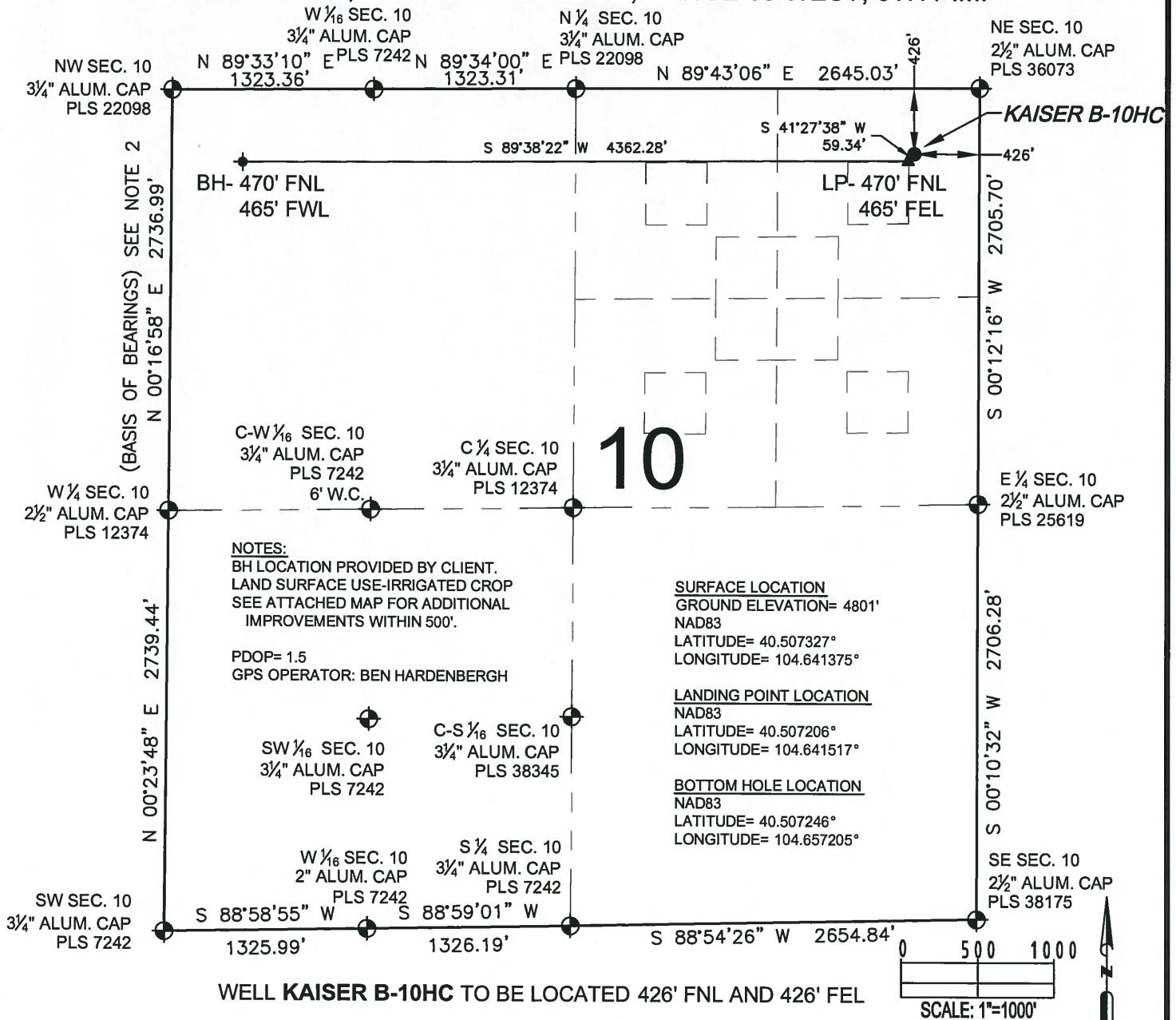


WELL LOCATION CERTIFICATE: KAISER B-10HC

LEGEND

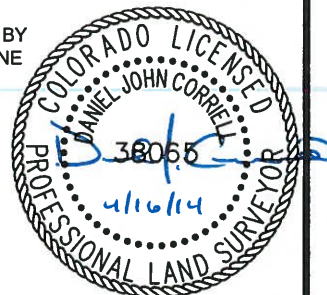
- = EXISTING MONUMENT
