#### COMMENTS:

WPX Energy has the need to set 2-300 bbl tanks inside a lined metal containment on the GV 88-1 PAD (Section 1 in 7S95W) where we have a small tank facility already in use.  
The tanks will be used ONLY for emergency oil transfers that come from the result of a leaking tank or some other reason we have to unload a production tanks contents.  
The tanks will be strapped and the calibrated tables sent to local BLM office once we get them.  
The tanks will be labeled with proper NFPA and contents stickers.  
The tanks will consist of only a sales, inlet and drain valve. These valves will all be sealed in accordance with On-shore order #3. A seal log of all seals will be kept by WPX and available at all times. We will also lock the 3 valves.  
The tanks will only be accessible with a WPX supervisor approval.  
Should we have to load a tank in an emergency we will gauge the tank to be hauled prior to loading and contact the local BLM personnel immediately upon deciding we need to haul the product.

The wells on the GV 88-1 pad are as follows:  
GV 88-1, PA 43-1, PA 44-1, PA 333-1, PA 33-1, PA 344-1, PA 433-1, PA 434-1, PA 533-1, and PA 334-1.
