




WELL LOCATION CERTIFICATE


In accordance with a request from Al Bragg with PDC ENERGY Lat40°, Inc. has determined the surface location of the SCHNEIDER 19Q-402 to be 409' from the SOUTH line and 1577' from the EAST line as measured at right angles from the section lines of Section 19, Township 5 North, Range 64 West and the bottom hole to be 75' from the SOUTH line and 500' from the EAST line as measured at right angles from the section lines of Section 20, Township 5 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 1/16/2014, for and on behalf of PDC ENERGY. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
