From well head one 3" fiberglass pipeline approximatley 2795' to separator (heater-treater) at tank battery. From separator two 3" fiberglass pipelines approximately 150' to 3-300 bbl oil tanks, 1-300 bbl water tank. Plus addition of one 48" VOC combustion chamber at tank battery.
