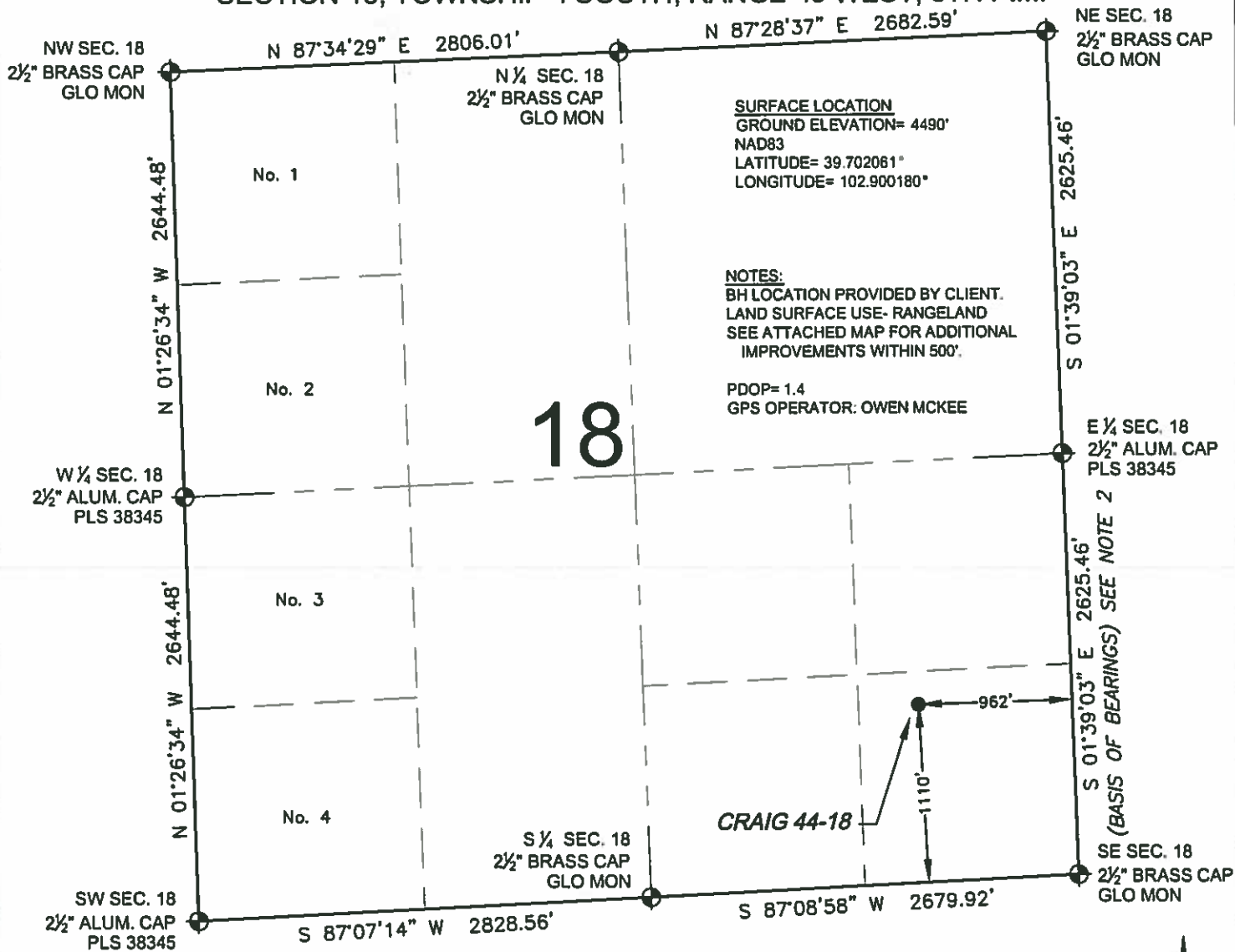


# WELL LOCATION CERTIFICATE: CRAIG 44-18

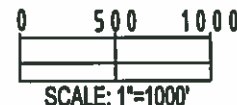
SECTION 18, TOWNSHIP 4 SOUTH, RANGE 49 WEST, 6TH P.M.

● = PROPOSED WELL   ◆ = EXISTING WELL

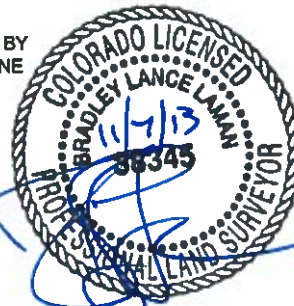
