## COMMENTS:

This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the RWF 342-33 pad in accordance with footnote 1 to the COGCC table 910-1.

The request is based on the analytical results presented below (see attached laboratory report).

One composite sample was collected from the cuttings trench to determine the arsenic concentration in the cuttings.

RWF 342-33 (cuttings) – 4.5 mg/kg

Five grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.

RWF 342-33-B-1 – 4.1 mg/kg

RWF 342-33-B-2 – 4.1 mg/kg

RWF 342-33-B-3 – 6.3 mg/kg

RWF 342-33-B-4 – 5.0 mg/kg

RWF 342-33-B-5 – 6.4 mg/kg

WPX Energy is requesting this approval in order to proceed with closure and reclamation of the cuttings trench located on the RWF 342-33 well pad.
