## COMMENTS:

OXY USA WTP LP (Oxy) is providing this 18-month status update as part of the conditions of approval for the previously approved 18-month Cascade Creek 697-15-01 Cuttings Disposal Area (697-15-01 CDA) interim reclamation request, reference approved document #02369026. As outlined in the previously submitted CDA 12-month status update (reference COGCC doc# 400493031), Oxy is planning on utilizing the 697-15-01 CDA to support drilling and completion activities for one well located on the 697-09-61 pad, and 12 wells on the 697-15-54 well pad. The drilling activities were originally scheduled for March 2014. These drilling activities have since been postponed until August 2014; therefore Oxy intends to postpone final reclamation of the 697-15-01 CDA until spring or summer of 2015. Oxy will continue to conduct quarterly sampling of ground water seeps located down gradient of the facility. Continued monitoring and inspections of stormwater, BMPs, and revegetation will be conducted as part of Oxy's stormwater program. Oxy will notify the COGCC once the site is re-opened for additional cuttings storage and disposal. All handling of the cuttings will be completed as discussed in document #2215578 including: transport, sampling, staging, mixing, final disposal, and closure.
