To Texas Tea of Colorado:

Our records show that as an operator of record for (an) existing well(s) in Colorado you have not submitted as-built latitude and longitude values for a well or a number of wells. Your company is out of compliance with this reporting requirement. Please submit as-built latitude and longitude coordinates for all wells on this list by June 1, 2014. You were notified of these requirements in November of 2013 and there has not been a response. Completion of this activity or an approved compliance plan must be received by June 1, 2014 to avoid the matter being referred to enforcement for action.

In the fall of 2005 all operators were mailed a *Notice to All Operators: Rule Changes Regarding Oil and Gas Well Location Reporting*. A copy of the letter is included with this emailing.

· The letter refers to COGCC requirements to report as-built latitude and longitude for all wells existing as of October 31, 2005 and allows five years to record and submit those values to the COGCC. That due date was December 1, 2010.

· The letter makes reference to Rule 215 which stipulates the capabilities required of the GPS instrument.

The wells missing as-built lat/longs are being sent to you in a spreadsheet format. However, these lat/longs now must be submitted either on a Form 4 Sundry Notice for the old wells or a Form 5 Drilling Completion Report for the newly drilled wells. The spreadsheet is no longer an acceptable format to submit any as-built lat/longs.
