Encana requests the following changes for all wells on the subject pad:

After careful consideration, torque and drag modeling, solids control analysis and offset steering/mitigation concerns, it was determined that utilizing synthetic oil based mud (OBM) for the extended length laterals on subject pad proves to be the most cost effective and productive for drilling operations.

The Surface, intermediate, and curve sections will be batch drilled with WBM (water-based mud) to 7" casing point and cemented in place. Upon completion of the intermediate/curves, the drilling fluids system will be changed out to synthetic based oil mud. The entire rig footprint will have secondary containment (liner) to prevent any spills or environmental concerns.

WBM Disposal:

Disposal of WBM cuttings will continue under current Encana operating procedures. Cuttings caught in low sided bin (off of shakers), mixed with mulch and transferred to holding bin. Cuttings are then loaded out and taken to licensed land spread facility.

Disposal of OBM cuttings will be as follows:

Cuttings caught in low sided bin (off of drying shakers), and transferred to lined holding bin. Cuttings will be hauled to a licensed facility where they will be disposed of according to regulations. Under no circumstances will OBM cuttings be land spread.
