Alex,

Ursa is submitting the attached Site Investigation and Remediation Workplan (Form 27) for the closure of the Form 15 & 28 permitted - Lundgren Centralized E&P Facility. Since Ursa acquired the asset in April of 2013, the facility has not been used, nor is it anticipated to be used by Ursa.

As outlined in COGCC Rule 908.g(2), this Form 27 is being submitted 60 days prior to any closure activities occurring. Ursa would like to begin the closure and site investigation process mid to late June 2014.

In addition to the Form 27, attached is the wetland evaluation summary that was completed by Antero Resources in 2008, which acted as the sensitive area determination at the time of permitting. A revised sensitive area determination will be completed prior to closure activities begin and will be attached to the final Form 27 closure.
