Axia Energy (Axia) has temporarily stored drill cuttings generated from a single well pad (Currey 16-10) and relocated them to the Kimball Creek 23-4C-995 pad in accordance with the Axia Cuttings Management Plan and approved Form 4 Sundry Notice Document 1949167. The temporary storage location is on lands owned by Axia in Mesa County, Colorado.

Subsequent to our determination that the stored cuttings can accommodate the COGCC Table 910 limits, the cuttings will be beneficially reused at the Kimball Creek 23-4C-995 location.

Axia has previously submitted the Drill Cuttings Materials Management Plan outlining its cuttings disposal and storage plan at the above mentioned location (see document number 1949167).

Axia requests review and approval of this Form 4 Sundry Notice in order to beneficially reuse the cuttings on the Kimball Creek 23-4C-995 Pad.
