Angie,

I have completed my review of the above referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) You have indicated there will be a Freshwater Storage Pit on this oil and gas location; therefore, I will add it to the Facilities list.
- 2) Your pipeline description is incomplete given that you have proposed numerous wells, tanks, separators, compressors, and flares for this oil and gas location. Please provide a description (number, size, material, buried or not, pressurized or not) for all oil, gas, and/or water pipelines on this oil and gas location.
- 3) During my review it appears that the nearest downgradient surface water feature is greater than a mile from this oil and gas location. Therefore, I will change that distance to 5,280 feet in the Water Resources section.
- 4) During my review it appears the nearest existing water well is greater than a mile from this oil and gas location. The permit for the water well you identified as 2,600 feet from the oil and gas location indicates it has been abandoned. Therefore, I will change the distance to 5,280 feet in the Water Resources section.

I have gotten the following information regarding number 2 of your email below from the completions engineer. The pipeline information below is intended to be the same for Form 2A's Document numbers: 400596985, 400596540, 400595808, and 400595398.

The gas pipeline will be owned by Sterling Energy. Each pad will be connected to a single gas sales line:

Gas Pipeline:

- Size: 2"
- Material: Fiberglass
- Buried
- Pressure up to 125#

Temporary water transfer line:

- Size: 4-6"
- Material: Aluminum pipe and/or Polyrethane hose
- Surface (temporary)
- Pressure 0-? – I don't expect much pressure if any.
