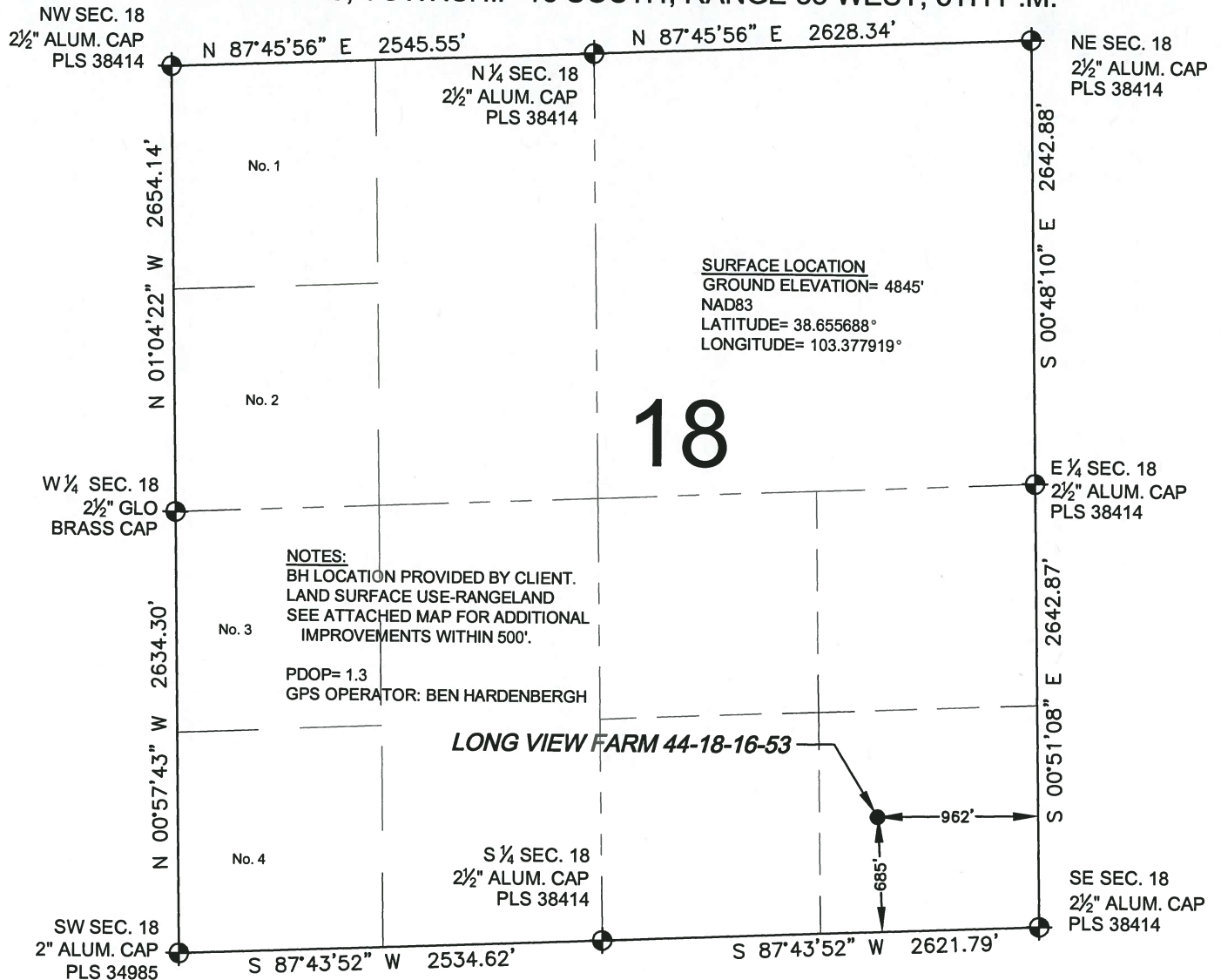
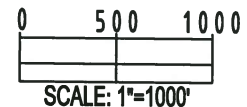


WELL LOCATION CERTIFICATE: LONG VIEW FARM 44-18-16-53
