COMMENTS:

This well was recently identified as having high bradenhead pressures. There is a good cement bond above the top perf. The bradenhead valve was shut with a pressure observed at 183 psi (10/15). WPX would like to vent the bradenhead to a tank to see if the pressure dissipates, and do a shut-in/build-up test afterwards to determine if the pressure has fully dissipated or if we need to remediate.
