Based on newly acquired knowledge of the area since the original application for sidetrack was submitted, Entek feels that the following changes are necessary for production enhancement in this well. The directional plan is being revised to the south west to accommodate geologic concerns. The mud program is being upgraded to OBM to minimize water invasion into the formation. The casing program is being revised to better accommodate production testing and the cement program has been revised to accommodate the new casing plans. This well is still planned as a sidetrack from the originally drilled hole. The sidetrack depth is not changing, nor is the bottomhole footage calls, only the direction of the sidetrack hole and the mud type. Please see the revised drilling program and attachments for more details about the 2014 drilling operation plan for this well.
