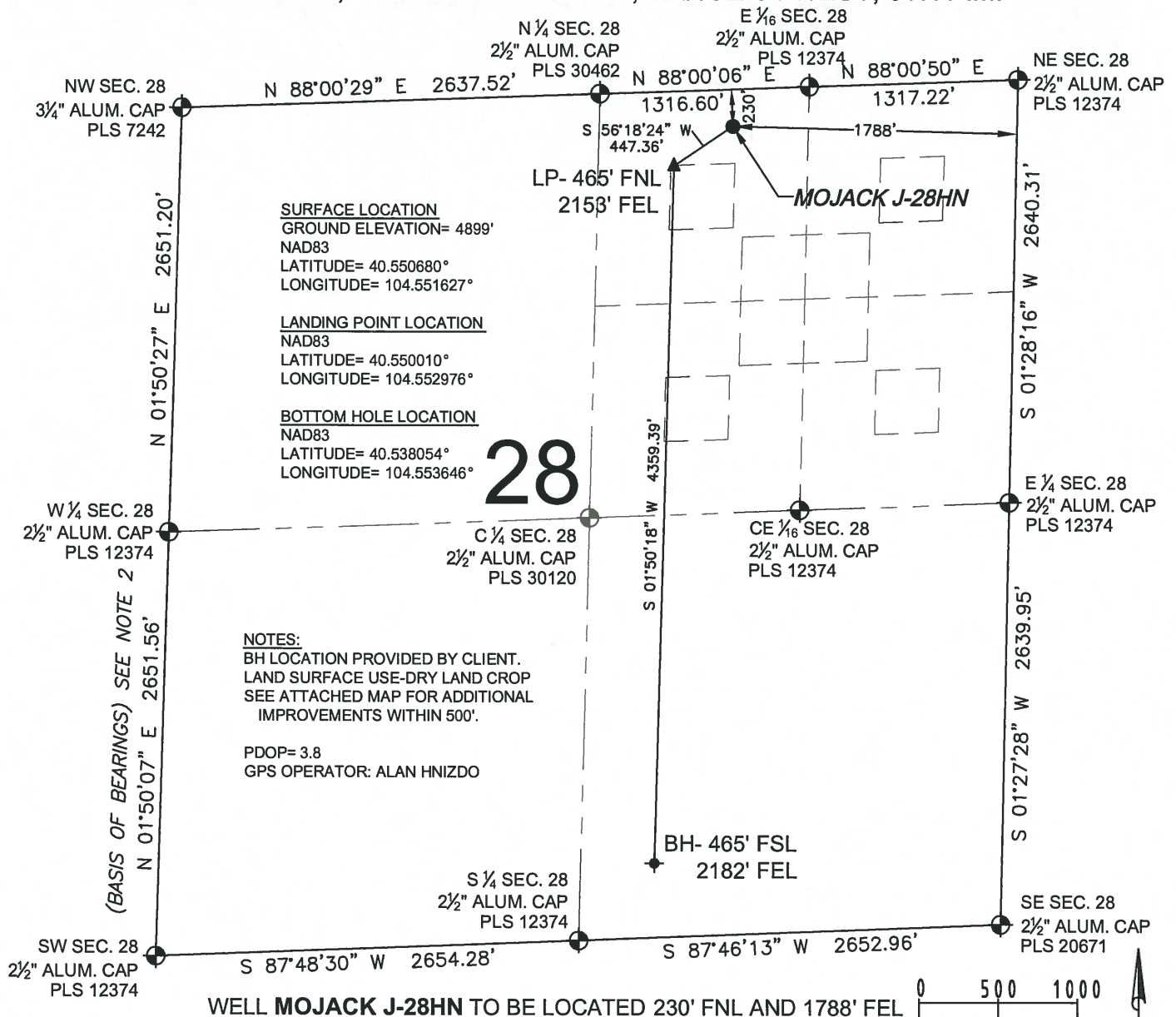


WELL LOCATION CERTIFICATE: MOJACK J-28HN

LEGEND

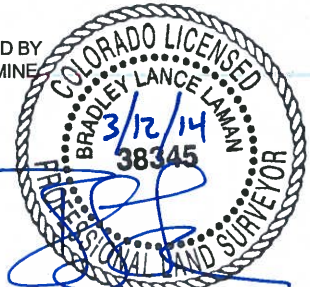
- = EXISTING MONUMENT ▲ = LANDING POINT
